# ITINERARY

## Friday, August 23 - Departure

Depart the USA to Switzerland.

## Saturday, August 24 - Geneva, Lausanne

Upon arrival, we will meet our tour guide and driver. Board our motor coach and enjoy a panoramic tour of the city. Continue with a walking tour throughout the historical streets to the Cathedral of San Peter and the historical city centre. In the afternoon, we will continue to Lausanne.

## Sunday, August 25 - Lausanne

Today, we will enjoy a relaxing day dedicated to a boat ride along the south coast of the lake. Depart Lausanne in the morning, then, we will stop to visit the Chillon Castle. This romantic site was built on a rocky islet on Lake Geneva against a steep forest slope. Continue walking along the romantic, blooming path to arrive in Montreaux. It was mostly thanks to the success enjoyed by the works of Jean- Jacques Rousseau ("La Nouvelle Héloïse", 1761) and of Lord Byron ("Le prisonnier de Chillon", 1816) that the Montreux Riviera began to attract its first visitors. After lunch, we will return to Lausanne for an afternoon at leisure. Dinner and overnight at our hotel.

## Monday, August 26 - Lausanne, Gruyeres, Bern, Interlaken

After breakfast, we will drive to the medieval town of Gruyeres, home to the finest Swiss cheese and chocolate. Here, we will have the opportunity to visit the the cheese factory and to discover the production of the Swiss Gruyère AOP and taste cheese specialties. Then we will continue to Bern. After lunch, we will enjoy a walking tour of the city centre. In the afternoon, we will continue to Interlaken.

## Tuesday, August 27 - Interlaken

This morning, we will take the panoramic cables up to Mt. Jungfrau. Break for lunch at the Schilthorn restaurant, which once was part of a 007 movie set. In the

afternoon, we will return to Interlaken for a great opportunity of shopping and leisure. Explore the food culture as you enjoy dinner on your own.

## Wednesday, August 28 - Interlaken, Lucerne

Today, we will continue our drive to Lucerne. Upon arrival, some free time in the city centre for shopping and independent lunch. In the afternoon, we will enjoy an enchanting lake cruise to admire the incredible views of Mount Pilatus and Rigi in the Swiss Alps.

## Thursday, August 29 - Shaffhausen, Lucerne

After breakfast, we will drive to Shaffhausen to see Rheinfall, Europe's largest and most powerful waterfall. Take some free time to enjoy the waterfall. In the afternoon, return to Lucerne.

## Friday, August 30 - Lucerne, Milan

This morning, we will continue our drive to Milan. After lunch, we will visit the magnificent Duomo, the third-largest church in the world after St. Peter's in Rome and after the Cathedral of Seville. Here, we will celebrate Mass. Then, we will explore Montenapoleone Street, the fashion area of the city, and see La Galleria and La Scala Opera House.

## Saturday, August 31 - Milan, Turin, Milan

After breakfast, we will depart for the city of Turin, where we will celebrate Mass at the church of Maria Ausiliatrice. Completed in 1868, this church was originally part of a home for poor boys founded by Saint John Bosco, which now contains his tomb with the relics of St. Dominic Savio and other saints. Then, we will enjoy a guided tour of the city including Piazza Castello, and the Cathedral of St. John the Baptist, where Blessed Giorgio Frassati is buried and the Holy Shroud is preserved. In the afternoon, we will return to Milan.

## Sunday, September 1 - Departure
