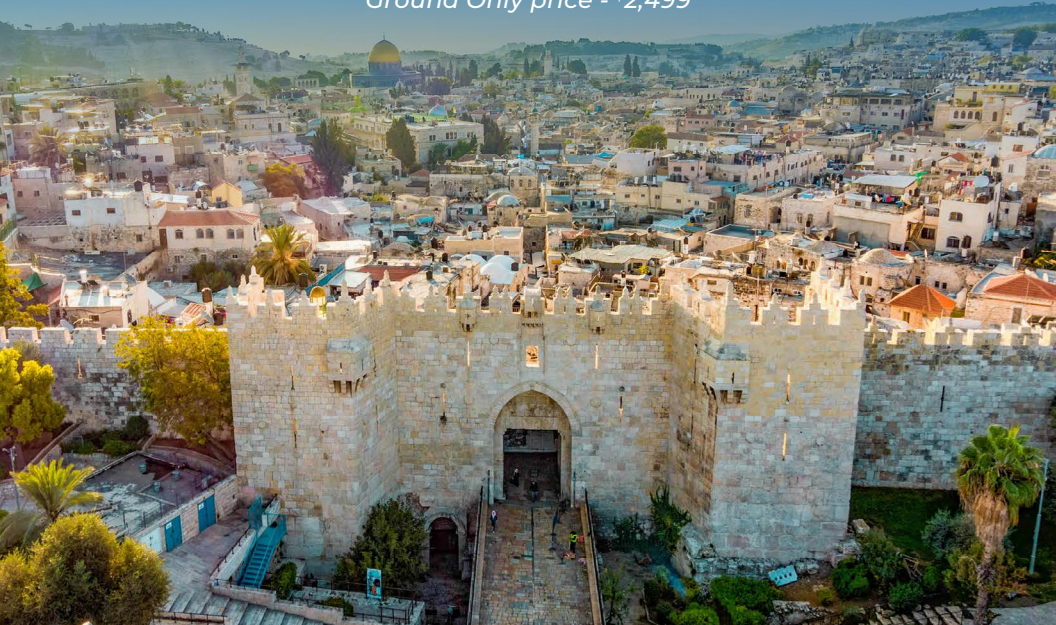

Monday, April 10, 2023
Depart Los Angeles

Our pilgrimage to the Holy Land begins as we depart Los Angeles on LH457 at 3:00pm.

Tuesday, April 11, 2023

Arrive Frankfurt at 10:50am and connect with LH694 departing Frankfurt at 2:00pm. Arrive Tel Aviv airport at 7:05pm where we will be welcomed by our tour guide and bus driver. Transfer to the hotel in Bethlehem for a late dinner and good night sleep

Wednesday, April 12, 2023
Bethlehem/Mount of Olives/Garden of Gethsemane/Ein Karem

This morning, we visit the Church of the Nativity, Holy Manger, the Basilica of St Catherine, the Shepherds' Field and then continue to the Mount of Olives, Garden of Gethsemane with the Church of All Nations. On the way back to Bethlehem, we stop in Ein Karem to visit the Church of Visitation.

Thursday, April 13, 2023
Old City of Jerusalem/Mount Zion

We start our walk with the Church of St. Anne, Pools of Bethesda and continue through the 14 Stations of the Cross until we reach the Church of the Holy Sepulcher to see the empty tomb and Golgotha. We walk through the Old City to the Wailing Wall and on to Mount Zion and the Church of St. Peter in Gallicantu

Friday, April 14, 2023
Emmaus/Samaria/Jacob's Well

Today, we will enjoy a trip to Emmaus where Jesus appeared to two of His disciples on the day of His resurrection. Continue to Samaria to view Mount Ebal and Mount Garizim and to Jacob's Well.

Saturday, April 15, 2023
Bethany/Jericho/River Jordan

We drive to Bethany, known as the place where



Jesus raised Lazarus from the dead. Continue through the Judean Desert to Jericho to view Mount of Temptation and from here we continue to the baptismal site on the River Jordan.

Sunday, April 16, 2023
Old Jaffa/Caesarea/Haifa/Nazareth

Depart our hotel in Bethlehem and drive through Abu Ghosh to Old Jaffa to visit the Church of St. Peter and enjoy a view of Tel Aviv. On to the ruins of ancient Caesarea with a stop at the Aqueudct. Continue to Haifa and Mount Carmel to visit the Church of the Prophet Elijah. Arrive Nazareth later in the day

Monday, April 17, 2023
Nazareth/Cana/Sea of Galilee region

This morning, we visit the Basilica of the Annunciation and on to Cana where Jesus performed His first public miracle at the wedding. We will have the opportunity to renew our wedding vows and on to the Sea of Galilee to visit Capernaum, Mount Beatitudes, Tabgha and enjoy a boat ride on the Sea of Galilee.

Tuesday, April 18, 2023
Nazareth/Jordan

Today, we take a leisurely drive to the border crossing to Jordan where we will be welcomed by our tour guide and bus driver. On to our hotel on the shores of

the Dead Sea for free time to enjoy the salty and warm water.

Wednesday, April 19, 2023
Petra

We drive to Petra for an unforgettable visit of the "rose red" city. We begin at the Siq, a winding canyon road and at the end of the passage we see Petra's most beautiful monument "The Treasury" We will also see tombs, a theater and in the afternoon we return back to our hotel.

Thursday, April 20, 2023
Madaba/Mount Nebo/Amman

This morning, we visit Madaba and the church, home to a beautiful 6th century mosaic map of the Holy Land and Jerusalem. On to Mount Nebo where we view the Promised Land as Moses did. Drive to Amman for a panoramic tour of the capital of Jordan. Early dinner and overnight
