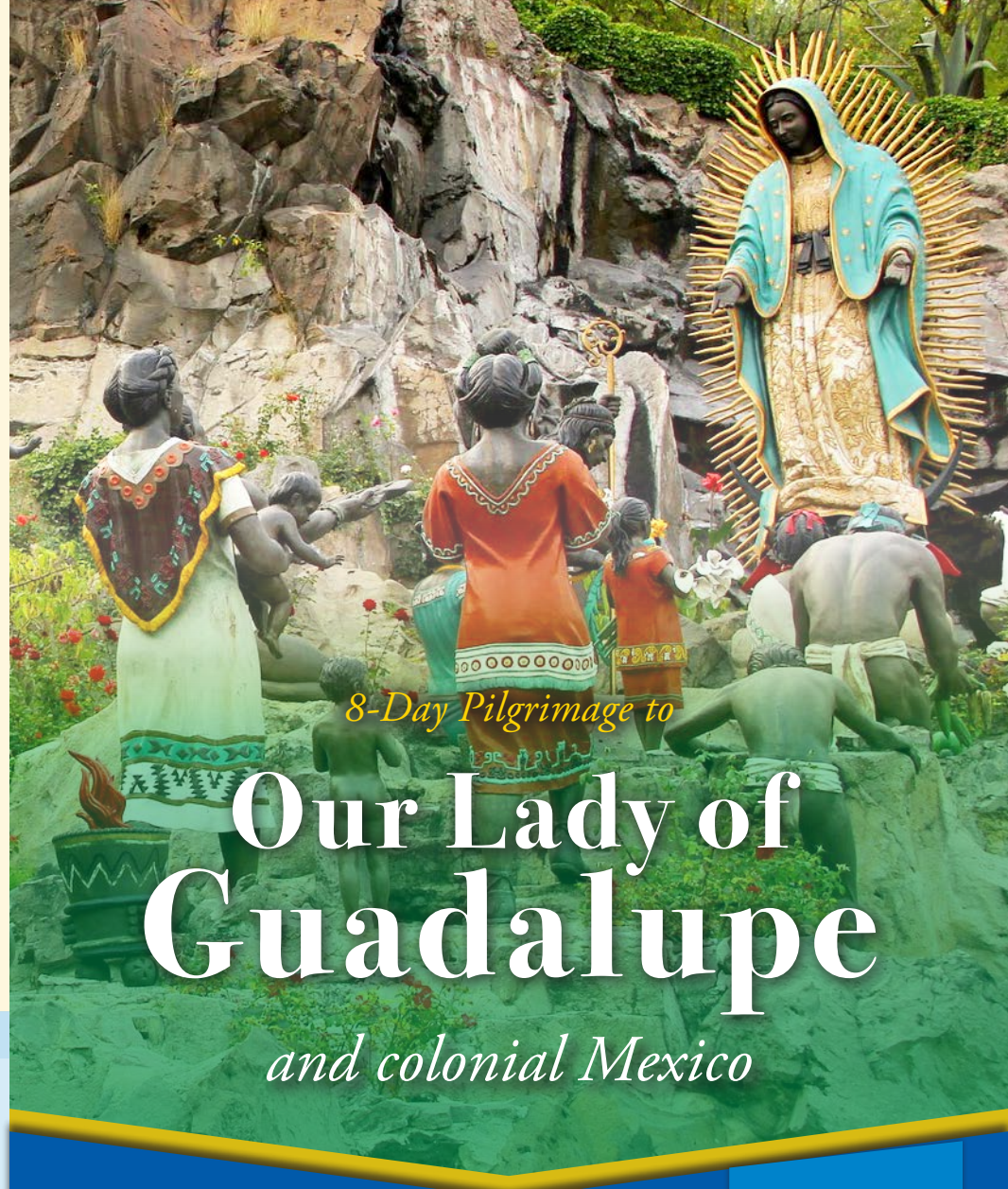

Monday, December 9, 2024

Departure

Depart on flight AA2546 to Mexico City, arriving at 1:53pm. We will meet the tour guide and bus driver. Transfer to our hotel.

Tuesday, December 10, 2024

Shrine of Guadalupe, Mexico City

We will spend the day in Mexico City. Visit the impressive complex and one of Mexico's holiest shrines, "Our Lady of Guadalupe." Visit the New Basilica that houses the sacred image of the Virgin (Tilma), and the Old Basilica. Walk up Tepeyac Hill and the surrounding gardens. Then, a panoramic city tour includes the Plaza of the Three Cultures, the Zocalo, the Metropolitan Cathedral, and the National Palace.

Wednesday, December 11, 2024

Cuernavaca, Taxco

Depart Mexico City with a scenic drive

to Cuernavaca, the "eternal springs" city. Here, we will explore the beautiful garden of the market and the church area. Then, we will visit the famous silver mining town of Taxco, nestled in the rugged mountains of the Sierra Madre. We will stroll through the cobblestone streets, visiting Santa Prisca Church with its Baroque altarpieces. Enjoy leisure time for shopping before returning to Mexico City.



Thursday, December 12, 2024

Mexico City, Teotihuacan, Xochimilco

This morning, we will drive to the neighborhoods of San Angel and Coyoacan with their colonial buildings, churches, and lively public squares. Then, we will drive to Teotihuacan, one of the best-

preserved ancient cities in Mexico. Countless monumental structures, including the pyramids of the Sun and Moon, frame the mile-long Avenue of the Dead. Today, we will also visit Xochimilco, the floating gardens.

Friday, December 13, 2024

Puebla, Tlaxcala, Our Lady of Ocotlan

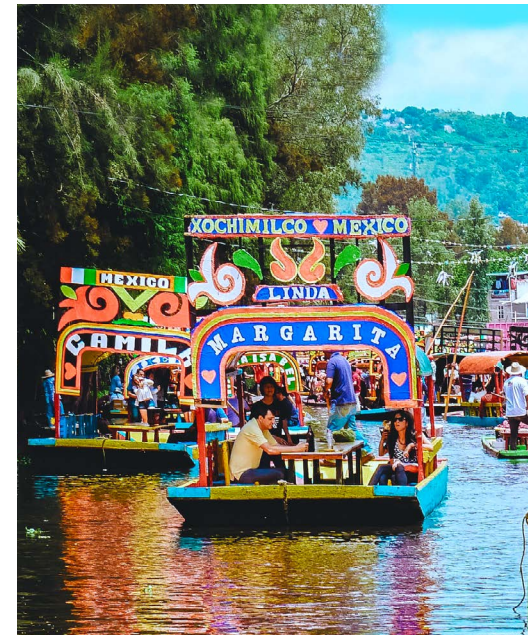
After breakfast, we will depart to Puebla. We will visit the Cathedral, Santo Domingo Church with the beautiful Dome of the Rosary Chapel, and later browse a little in the marketplace before continuing to Tlaxcala and the Shrine of San Miguel del Milagro, where St. Michael the Archangel appeared to Juan Diego Lazaro and told him of a miraculous spring. Continue to Ocotlan to visit the pilgrimage church and see the image of Our Lady, where an apparition to Juan Diego in 1541 was miraculously burned into

the trunk of an Oak Tree. Overnight in Puebla.
