Countless monumental structures, including the pyramids of the Sun and Moon, frame the mile-long Avenue of the Dead. Today, we will also visit Xochimilco, the floating gardens.

## Friday, December 13, 2024 Puebla, Tlaxcala, Our Lady of Ocotlan

After breakfast, we will depart to Puebla. We will visit the Cathedral, Santo Domingo Church with the beautiful Dome of the Rosary Chapel, and later browse a little in the marketplace before continuing to
